WR3 Awards Committee Chair; Administrator of the Drinking Water State Revolving Fund Program, Florida Department of Environmental Protection, Iron woman and proud mother of two! **Ms. Speas-Frost** had been a driving force behind the former FWEA water reuse committee and now provides expert assistance to the new WR3 committee. Shanin, who has been with the

Florida Department of Environmental Protection (FDEP) in Tallahassee for over sixteen years, was recently promoted to Administrator of the Drinking Water State Revolving Fund Program (SRF). Shanin had held the position of the State Water Reuse Coordinator for eight years, dealing with issues regarding implementation of Florida Water Reuse program as well as wastewater treatment wetlands. She graduated from the University of Florida with a bachelor's degree in Environmental Engineering in 1995 and went to work at a Florida paper mill where she managed their wastewater treatment process. In 2001, she graduated from the Florida State University with a Master of Business Administration and in 2002 received her licensure as a Professional Engineer in the state of Florida. Shanin is active in the Florida Water Environment Association (FWEA) serving as chair of the Big Bend Chapter, coordinator of the Florida Water Festival of the Big Bend Area, and on the board of the Water Resource, Reuse and Resiliency Committee. She is also a standing member of the Integrated Water Management Advisory Committee for the national Water Research Foundation. St. Johns River Water Management District (SJRWMD) and Southwest Florida Water Management District (SWFWMD) Boards approve regional water supply plan strategies for

central Florida The Central Florida Water Initiative (CFWI) is an ongoing water supply effort focusing on the Central Florida Coordination Area, which includes southern Lake, Orange, Osceola, Seminole and Polk counties. The three water management districts, along with the Florida Department of Environmental Protection (DEP), Florida Department of Agriculture and Consumer Services (DACS), regional public water supply utilities and other stakeholders are collaborating to develop a unified process to address central Florida's current and long-term water supply needs. The Central Florida Water Initiative's (CFWI) Steering Committee has produced a report that will set a path forward for meeting water supply needs in central Florida for the next 20 years. This report is available now can be found on their website at <u>www.cfwiwater.com</u>. The SJRWMD and SWFWMD recently approved this report at their boards meeting.
