



FWEA Safety Corner

Currently, all public employers and employees are exempt from any Federal Occupational Safety and Health Administration (OSHA) safety requirements, but on December 18, 2008, the Florida Public Task Force on Workplace Safety provided recommendations to Governor Charlie Crist, regarding the need and potential future applicability of OSHA laws. The majority of task force members recommended passing legislation to require all public employers and employees to comply with OSHA safety rules within 3 years.

In addition, House Bill 967 was introduced on June 10, 2008 to address safety compliance for public employees. The last session of the Florida Legislature failed to act upon this initiative. However, this bill may be reintroduced during reconvening of the legislature, which is scheduled for March 2 through April 30, 2010.

For those who may not yet understand the complexities of full compliance with OSHA, it is

strongly recommended that you begin to address these requirements well before the deadline, since there is a long lead-time to develop and maintain a full safety training and compliance program.

At the very least, whether it is mandatory or not, it is always best to begin implementation of a voluntary safety compliance program to decrease risks, reduce costs, and ensure the safety of Florida's public employees.



Seasonal Storage of Reclaimed Water for the Englewood Water District by Mark McNeal, P.G.

Abstract

This presentation will discuss the history and experience of the development and operation of the Englewood Water District Reclaimed Aquifer Storage and Recovery (ASR) project, the first permitted and operational reclaimed water ASR Well in Florida.

Mark McNeal, P.G.

Mr. Mark McNeal developed and obtained permitting for the first reclaimed water ASR well in Florida while working for the Englewood Water District. He is currently the Chief Executive Officer for ASRus, LLC. Mr. McNeal has more than 24 years of experience in hydrogeologic investigations in Florida, including

management of projects for ASR, deep injection wells, reuse, and computer modeling of groundwater systems. He also has experience in aquifer pumping test design and analysis, ASR and water supply system startup, and ASR operational cycle testing. He has worked with water suppliers and water management districts across Florida, including the Southwest Florida Water Management District, South Florida Water Management District, and the Peace River/Manasota Regional Water Supply Authority. Mr. McNeal worked with CH2M HILL in their Tampa office for 21 years, where he was Director of Groundwater Practices and Reuse for their Southeast Region. Mr. McNeal obtained his B.S. in Geological Engineering from Brigham Young University.
